

## **Hysbysiad Preifatrwydd - Cofnodion Lechyd**

Ein nod yw darparu gofal o'r ansawdd uchaf i gleifion. Er mwyn gwneud hyn, rhaid i ni gadw cofnodion amdanoch chi a'r gofal yr ydym yn ei ddarparu ar eich cyfer.

Cedwir cofnodion iechyd ar bapur ac yn electronig ac mae'n ddyletswydd gyfreithiol arnom i gadw'r rhain yn gyfrinachol yn gywir ac yn ddiogel bob amser yn unol â chyfreithiau diogelu data.

Hyfforddir ein staff i ymdrin â'ch gwybodaeth yn gywir er mwyn diogelu eich preifatrwydd. Ein nod yw cynnal safonau uchel, mabwysiadu'r arferion gorau ar gyfer cadw cofnodion a gwirio'r hyn rydym yn ei wneud yn rheolaidd a chyflwyno adroddiad arno. Nid yw eich gwybodaeth byth yn cael ei chasglu at ddibenion marchnata uniongyrchol, ac nid yw'n cael ei gwerthu i unrhyw bartïon eraill.

Weithiau gall aelodau tîm gofal ddarparu eich gofal, a allai gynnwys pobl o sefydliadau eraill megis iechyd; gofal cymdeithasol; sefydliadau addysg neu ofal eraill. Cedwir gwybodaeth am gyfnodau penodedig o amser fel y nodir yn y cod ymarfer rheoli cofnodion ar gyfer iechyd a gofal cymdeithasol.

Mae gwybodaeth sy'n cael ei chasglu amdanoch chi i ddarparu eich gofal iechyd hefyd yn cael ei defnyddio i helpu gyda'r canlynol:

- sicrhau bod eich gofal o safon uchel.
- Defnyddio gwybodaeth ystadegol i ofalu am iechyd a lles y cyhoedd yn gyffredinol a chynllunio gwasanaethau i ddiwallu anghenion y boblogaeth
  - asesu eich cyflwr yn erbyn meini prawf risg penodol er mwyn sicrhau eich bod yn cael y gofal gorau posibl.
- Paratoi ystadegau ar ein perfformiad ar gyfer yr adran iechyd a chyrrff rheoleiddio eraill.
- Helpu i hyfforddi staff a chefnogi ymchwil.
- Cefnogi'r cyllid ar gyfer eich gofal.
- Adrodd ac ymchwilio i gwynion, hawliadau a digwyddiadau anffodus.
- Adrodd digwyddiadau i'r awdurdodau priodol pan fydd yn ofynnol i ni wneud hynny yn ôl y gyfraith.

Y sail gyfreithiol dros brosesu data at y dibenion hyn yw bod y GIG yn awdurdod swyddogol sydd â dyletswydd gyhoeddus i ofalu am ei gleifion, a rheoli'r systemau a'r gwasanaethau iechyd neu ofal cymdeithasol.

Mae gennych hawl i ofyn i ni beidio â defnyddio eich gwybodaeth fel hyn. Fodd bynnag, mae eithriadau i hyn sydd wedi'u rhestru isod. Credir bod budd y cyhoedd yn bwysicach er enghraifft:

- Os oes trosedd ddifrifol wedi'i chyflawni
- Os oes risgiau i'r cyhoedd neu i'n staff

• i amddiffyn plant neu oedolion sy'n agored i niwed • Mae gennym ddyletswydd gyfreithiol, er enghraifft cofrestru genedigaethau, rhoi gwybod am rai clefydau heintus, clwyfo gan ddrylliau a gorchmynion llys.

• Mae angen i ni ddefnyddio'r wybodaeth ar gyfer ymchwil feddygol. Rhaid inni ofyn caniatâd y grŵp cynghori ar gyfrinachedd (a benodwyd gan awdurdod ymchwil iechyd y GIG)

Mae Deddfau Diogelu data yn rhoi hawliau i unigolion o ran y wybodaeth bersonol a gedwir amdanoch. Y rhain yw:

1. cael gwybod pam, ble a sut y byddwn yn defnyddio eich gwybodaeth
2. Gofyn am gael gweld eich gwybodaeth
3. Gofyn i'ch gwybodaeth gael ei chywiro os yw'n anghywir neu'n anghyflawn
4. Gofyn i'ch gwybodaeth gael ei dileu neu ei dileu lle nad oes angen i ni barhau i'w phrosesu.
5. gofyn i ni gyfyngu ar y defnydd o'ch gwybodaeth
6. Gofyn i ni gopïo neu drosglwyddo eich gwybodaeth o un system TG i'r llall mewn ffordd ddiogel, heb effeithio ar ansawdd y wybodaeth
7. I wrthwynebu sut y defnyddir eich gwybodaeth
8. Herio unrhyw benderfyniadau a wnaed heb ymyrraeth ddynol (gwneud penderfyniadau'n awtomataidd)

## **Privacy Notice – Patient Records**

We aim to provide you with the highest quality patient care. To do this, we must keep records about you and the care we provide for you.

Health records are held on paper and electronically and we have a legal duty to keep these confidential, accurate and secure at all times in line with Data Protection Laws.

Our staff are trained to handle your information correctly to protect your privacy. We aim to maintain high standards, adopt best practice for our record keeping and regularly check and report on how we are doing. Your information is never collected for direct marketing purposes, and is not sold on to any other third parties.

Sometimes your care may be provided by members of a care team, which might include people from other organisations such as health; social care; education or other care organisations.

Information is held for specified periods of time as set out in the Records Management Code of Practice for Health and Social Care.

Information collected about you to deliver your health care is also used to assist with:

- Making sure your care is of a high standard.
- Using statistical information to look after the health and wellbeing of the general public and planning services to meet the needs of the population
- Assessing your condition against a set risk criteria to ensure you are receiving the best possible care.
- Preparing statistics on our performance for the Welsh Government and other regulatory bodies.
- Helping train staff and support research.
- Supporting the funding of your care.
- Reporting and investigation of complaints, claims and untoward incidents.
- Reporting events to the appropriate authorities when we are required to do so by law.

The legal basis for the processing of data for these purposes is that the NHS is an official authority with a public duty to care for its patients, and the management of the health or social care systems and services.

You have the right to ask us not to use your information in this way. However, there are exceptions to this which are listed to below.

- The public interest is thought to be of greater importance for example:
- If a serious crime has been committed
- If there are risks to the public or our staff
- To protect vulnerable children or adult
- We have a legal duty, for example registering births, reporting some infectious diseases, wounding by firearms and court orders.

- We need to use the information for medical research. We have to ask permission from the Confidentiality Advisory Group (appointed by the NHS Health Research Authority)

We may use outsourced providers or data processors that are based outside of the UK. Should your data be transferred outside of the UK, we will ensure in accordance with Data Protection legislation that the data will only be transferred where there is an adequacy regulation or other appropriate safeguard in place.

Data Protection laws gives individuals rights in the respect of the personal information that we hold about you. These are:

1. To be informed why, where and how we use your information
2. To ask for access to your information
3. To ask for your information to be corrected if it is inaccurate or incomplete
4. To ask for your information to be deleted or removed where there is no need for us to continue processing it.
5. To ask us to restrict the use of your information
6. To ask us to copy or transfer your information from one IT system to another in a safe and secure way, without impacting the quality of the information
7. To object to how your information is used
8. To challenge any decisions made without human intervention (automated decision making)
